


Blue Coin Select 20 Bond is a physically backed exchange traded product (ETP) that offers investors a simple, safe and cost-effective way to gain diversified exposure to the crypto asset market.

Blue Coin Emissions GmbH holds the underlying crypto assets in cold storage equal to 100% of the value of the Blue Coin Select 20 bond with a Bafin-licensed custodian in Germany.



- 1. Issuance of the bond in Germany.
- Blue Coin Emissions GmbH manages the proceeds from the sale of the bond for the bond investors.
- 3. The issue proceeds are invested in up to 20 selected coins (= basket).
- 4. The coins in the basket are equally weighted.
- 5. A rebalancing is carried out at the end of each month.
- 6. The acquired coins serve as 100% collateral for the bond.
- 7. The Blue Coin Select 20 bond directly tracks the performance of the acquired coins (basket).


